PREFACE

As laid down in the *Wet op het hoger onderwijs en wetenschappelijk onderzoek*—i.e. the Dutch Act on Higher Education and Scientific Research (WHW 7.12b-5), the Examination Board of the Bsc & MSc programs Mechanical Engineering (ME) and the MSc program Sustainable Energy Technology (SET), as part of the Faculty of Engineering Technology (ET) of the University of Twente, is required to annually report her activities.

In this annual report, the Examination Board ME/SET summarizes and accounts for its activities over the period January 2021 up to and including August 2022. This period (longer than a year) was chosen, upon request of the dean of the Faculty of Engineering Technology (ET), as a transition to report the activities per academic year, rather than per calendar year. Hence, as of September 2022, the annual report will covering academic years.

The Examination Board ME/SET defines the function of its annual reports as one of the means in a *Plan-Do-Check-Act* (PDCA) cycle. This annual report is based on factual and verifiable information, but not traceable to individuals.

1.3 **Capacities, tasks and responsibilities of the Examination Board**

As laid down in the Dutch Act on Higher Education and Scientific Research (WHW, article 7.12), capacities, tasks and responsibilities are assigned to the Examination Board of ME/SET and is appointed by the dean of the Faculty of Engineering Technology (ET). Additional capacities, tasks and responsibilities of the Examination Board ME/SET are laid down in the Education and Examination Regulations (EERs) of the (BSc and MSc) ME programs and of in the EER of the MSc SET program. As such, the Examination Board determines whether a student meets the Final Qualifications (FQs) of the ME and SET programs and therefore can safeguard the quality of the diplomas of programs.

The capacities, tasks and responsibilities of the Examination Board ME/SET include, but are not limited to:

- quality assurance of exams test plans,
- appointment of examiners,
- decisions regarding requests of students regarding an individual course program, or a deviating course program, based on and in accordance with rules in the EER,
- signing diploma's,
- establishing and monitoring Binding Study recommendation (BSA) of first year students,
- handling requests and complaints of students (see section 2.2),
- handling (suspected) fraud cases (see section 2.2).

1.4 Mandates

The Examination Board has delegated well defined tasks to other officials in the organization of the Faculty of Engineering Technology (ET) and the University of Twente (UT), to handle standard (student) requests, complaints and situations that require standard and quick decisions. Mandates are documented in writing and archived. All decisions made by mandated staff are presented and discussed by the secretary at the meetings of the Examination Board by means of a "decision list". All non-mandated decisions are made by the Examination Board.

1.5 **Documentation and archiving**

Minutes, agenda's, and other documents, such as mandates and decisions of/by the Examination Board are archived by the secretary of the Examination Board on the shared computer P-drive (server) of the University of Twente, with restricted access only for members of the Examination Board. Decisions of the Examination Board are documented either in the minutes of the meetings of the of the Examination Board or in the so-called "decision list" (see section 1.3). Also, this list is archived.

2 ACTIVITIES OF THE EXAMINATION BOARD

This section provides a brief overview of a few major advisory and policy-related tasks that the Examination Board, in addition to its regular tasks, fulfilled in the period January 2021 up to and including August 2022.

2.1 Meetings

In the period January 2021 up to and including August 2022, The Examination Board ME/SET had 11 regular meetings, namely on:

- 2021: Feb. 15th, Apr. 4th, Jun. 6th, Aug. 30th, Oct. 10th, Dec. 20th.,
- 2022: Feb. 2nd, Mar. 21st, May, 2nd, Jun. 13th, Aug. 29th.

Most meetings have taken place on-line through MS TEAMS, either due to governmental measures to fight the Covid-pandemic or due to logistic/practical reasons.

2.2 Effects of the Covid-19 pandemic and decisions to mitigate its effects

It is no surprise that the Covid-19 pandemic also had a large effect on how the Examination Board ME/SET shaped and performed her responsibilities (see section 1.2), in the period January 2021 up to and including August 2022. That is, some strict rules, as laid down, in, for example, Education and Examination Regulations (EERs) of the (BSc and MSc) ME programs and of in the EER of the MSc SET program, have been relaxed, in order to mitigate unreasonable effects (such as too long delays) on students, due to governmental- and/or or institutional measures (e.g. lockdown) to fight the spread of the Corona-virus. Rules were only "relaxed" when the Examination Board ME/SET could/can still safeguard the quality of exams and the diplomas of the programs. The Examination Board ME/SET decided to adapt the rules, as listed in table 1 (on the next page).

By the end of academic year 2021-2022 the effects of the pandemic on students and lecturers and teaching were (more) under control, and most of the rules were rolled back, starting the academic year 2022-2023, see last column of Table 1.

2.3 **Student request, complaints and cases of fraud**

In the period January 2021 up to and including August 2022, the Examination Board has handled multiple student requests, including but not limited to requests for extra examinations or resits, requests for an exemption and requests for a non-standard study-program. Table 2 below provides an overview of the cases handled. This table also lists a number of fraud cases and complaints, which have been dealt with.

Statistical comparison of the (number of) cases to previous academic years is complicated by the fact that this annual report covers a period (January 2021 up to and including August 2022) which is longer than an academic year. Moreover, a steep increase in number of cases in previous academic was be attributed to the covid-19 pandemic. In the period January 2021 up to and including August 2022 a decrease in Covid-9 related was observed.

The Examination Board observes, like pervious academic years, that students are more assertive and "know where to find" the Examination Board for requests and complaints, etc.

2.4 BSc Mechanical Engineering at the VU in Amsterdam

In September 2019 the University of Twente and the Vrije Universiteit (VU) in Amsterdam, started a "satellite" BSc program in Mechanical Engineering at the VU in Amsterdam. The responsibilities if the Examination Board ME/SET also extents to the examinations, students, etc. of this program in Amsterdam, see the annual report of the Examination Board ME/SET of 2019 for details.

As both programs have the same ISAT code in CROHO, complaints etc by students in Twente and in Amsterdam are (to be) dealt with identically (of course) by the Examination Board ME/SET. However, the board of the VU was (and still is) more strict in interpretation of governmental Covid-19 measures than the board of the University of Twente in Enschede. For example, unlike in Enschede, no on-site exams were allowed in Amsterdam, and al examinations were "forced" to be taken on-line. This led to different rules and requirements for/between students in Amsterdam and in Enschede. The latter is undesirable.

In Amsterdam, on July 1st, 2022, it was celebrated that the first "batch" of Bsc VU students were awarded a Bsc diploma ME from the "satellite" Bsc program in Amsterdam. The festive ceremony was recorded and available for streaming at <u>https://www.livevideo.nl/#mechanicalengineering</u>

Starting September 1st, 2022, dr. P.C. Roos (Pieter) will "had over" his task as location manager of the BSc ME VU-UT Bsc ME program to dr. J.P. Schilder (Jurnan).

2.5 **Participation in UT Platform Examination Boards**

The Chair of the Examination Board ME/SET participates in meetings of the University wide *Platform of Examination Boards*. This platform regularly discusses best practices of/for Examination Boards, as well as aims at harmonizing rules and guidelines of examinations and quality assurance, which overarch the various educational programs at the University of Twente. In 2022, the platform started a discussion, also including the rector magnificus of the University of Twente, prof. A. Veldkamp (Tom), reflecting on the status of the platform, and whether it should get a more formal role.

2.6 **Diploma's and cum laude**

Table 3 lists the number of students who were awarded a Bsc or Msc degree, as well as the number of students who graduated cum laude—i.e. a "with distinction" degree.

2.7 **Reassessment of a limited number of internship grades**

The Examination Board found that, during the start of the academic year 2021-2022, (part of) the final grade of a limited number (~40) of MSc ME and SET students was established incorrectly. More specifically, one third of the final grade of the Internship was based on a grade determined by a supervisor at the company/institute at which the student carried out the Internship, who was not appointed as an examiner by the Examination Board. The Examination Board, Faculty Board, and the Program Boards of the Msc ME & SET programs collaborated successfully to correct this issue, by having the grade internship of the students involved reassessed by internal supervisors (university staff who are appointed as examiner). Future internships are graded by internal supervisors only. Details of the above activities are laid down in a report by the Examination Board.

2.8 Improving the skills and expertise of the Examination Board

Dr. Pozarlik (member of the Examination Board) is currently enrolled in the *Senior Examination Qualification* program of the University of Twente, aimed at, amongst others, members of the Examination Boards. Drs. M. de Haan (external member of the Examination Board) successfully completed the SEQ program in 2020. Both will use the knowledge obtained for quality assurance by evaluation of rules and procedures in place in the programs of ME and SET, as well as to continue the Board's process of test-quality assessments (e.g. by participating and working together with the other members of the examination board and the teachers on the evaluation of tests).

3 SELF-EVALUATION & OUTLOOK

Each year the ME / SET Examination Board evaluates its own functioning and formulates aspects to work on for the next (academic) year.

3.1 Self-evaluation January 2021 – August 2022

In 2022, in a meeting, the Faculty Board, represented by prof. Koopman (Bart) and prof. M.C. van der Voort (Mascha) and the chairs—i.e. prof. K.T. Geurs (Karst), prof. J. Henseler (Jörge) and prof. G.R.B.E. Römer (Gert-willem)— of the three Examination Boards of programs residing within the Faculty of ET, evaluated the function of the boards. It was concluded that the Examination Boards are "in control". Also, it was discussed whether the three Examination Boards could or should "merge" aiming at increasing efficiency of the Boards. It was concluded that there is no urgent reason the merge (the activities of) the Boards.

Also in 2022, a few members of the Examination Board ME/SET discussed, in a meeting, with ing. K.M. van Zuilekom (Kapser), secretary of the Examination Board of the Bsc & MSc program *Civil Engineering & Management* on good practices and procedures handled by the secretary and the Examination Board of *Civil Engineering & Management*. It was concluded that, due to the increasing number of cases to be handled a dedicated software tool could be useful.

Due to the increased number of cases handled by the (secretary of the) Examination Board ME/SET, the Faculty Board has been asked to provide extra administrative support to the secretary. The Faculty Board and the secretary are currently discussing the "shape and form" of this additional administrative support.

3.2 **Outlook to 2022-2023**

In the next academic year (2022-2023), the Examination Board plans to address the following:

- The Faculty Board ET, program director ME/SET, Faculty Council ET and the Examination Board ME/SET have all agreed to improve the efficiency of the procedure to establish Education and Examination Regulations (EERs) of the programs MSc& MSc ME and Msc SET. It is suggested that also the Program Committees (Dutch: OLC) of the ME and SET programmes join this initiative.
- Continue the evaluation of tests and test plans in Modules of the BSC program ME, as was initiated earlier.
- Evaluation of the effects of the Covid-pandemic on the quality of exams and fraud cases. What can/did we learn? Which (changed) rules (see section 2.2) should be rolled back, or kept/retained?
